## **Regular Board Meeting Minutes**

I. Call to Order: Terry Byers, Chairman

II. Approval of Minutes: May 18, 2023 Regular Meeting

Riggs moves to the financial audit presentation stating PARD is in good financial health, the revenue from the tax base is continuing to grow, and the only finding from the audit is to correct two IRA contributions on behalf of the two new employees added during the fiscal year.

J. Stevens touches on fireworks show preparations. T. Byers notifies board of an assessor oversight leading to Chappapeela taking in a small portion of PARD revenue. Will be corrected and reimbursed to PARD during 2024 fiscal year.

- A. Park Manager's Report Stevens informed the Board of cancelation of open play basketball due to ongoing vulgarity and violence, even after a security detail was obtained to oversee the games. Brings up that due to high interest from outside vendors, a vendor contract and fee schedule may need to be instituted before next year's fireworks display. Mentions re-visiting out-of-district fee at PARD, in order to stay consistent with the area standard. Touches on the dates of upcoming road closures that may affect PARD access.

- C. Chairman Remarks Byers closes the meeting by thanking members for their attendance and hopes to see all at annual fireworks show.
